IMPORTANT NOTICE TO ALL EXHIBITORS

Any exhibitors intending to bring electrical equipment to the Showgrounds will be required to ensure that such equipment is fitted with **earth leakage circuit breakers** and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor. This is essential for the safety of yourself, your fellow exhibitors and the general public, and is a requirement of the **Workplace Health and Safety Act of 1989**. The Act imposes severe penalties in the event of non-compliance with its provisions. Any exhibitors who do not comply will not be allowed to exhibit at the Stanthorpe Showgrounds. Please check all your electrical equipment and leads before you come to avoid any difficulties.

CONDITIONS

All exhibitors must ensure that exhibits are of Show standard. Exhibitors shall not assign or sub-let any part of allocated space without the consent of the Steward in writing. Every endeavour will be made to site Trade Space satisfactorily; however, the site allocated **MUST NOT** be changed without the approval of the Steward.

The Society reserves the right in unforeseen circumstance to amend or alter the exact site of the location of the exhibit, and the Exhibitor undertakes to agree to the alteration to the site or the space re-allocated by the Society.

Microphones, sound amplifiers and machine demonstrations will be permitted where the level of sound causes no annoyance to other Traders or the visiting Public.

Exhibitors are asked to have their own comprehensive insurance as the Association will **NOT** be held responsible for loss of goods or damage. All exhibitors **MUST** produce evidence of adequate current Public Liability Insurance cover, **which must name the Stanthorpe Agricultural Society as the interested party**, and be of an adequate amount.
